- Customers can add backup batteries at anytime, without effecting NEM status
- If you want to add panels a pre-existing system, it is recommended to do so by the end of Feb to ensure you meet the deadline

NEM 3 UPDATE:

NEM 2.0 is coming to an end! The value of solar exports will decrease dramatically starting in April 2023. By getting grandfathered into NEM 2.0, you will be able to lock your home's buyback rates for the next 20 years.

The financial incentives will drop by 75% for NEM 3 customers. The ROI will be close to double the amount of time for the payback period. To get the most out of your solar exports, act now!

What New Solar Customers Can Expect with NEM 3

- When you sell energy into the grid your rates will be credited at an average of close to 7 cents per kWh instead of what is currently being credited at an average of 40 cents per kWh
- These changes would require customers to be on electrification rates (E-ELEC, TOU-PRIME, EV-TOU-5), which have monthly charges of \$14-\$16.




